A Conciliator who makes his own arrangements for boarding, lodging, local transport etc. may be paid out of pocket expenses at the rate of Rs. 2000.00 per day, without production of vouchers.

Travel, Boarding & Lodging (CSCC & DACCC) Conciliator:

Local Sitting: Travelling allowance of Rs. 750.00 per sitting. Outstation Sitting: Actuals by Air, Rail or Car, plus out-of-pocket expenses at actuals for boarding, lodging and local transport subject to maximum of Rs. 5500.00 per day in Metropolitan cities and Rs. 6000.00 per day in other cities. A conciliator who makes his own arrangements for boarding, lodging, local transport etc. may be paid out of pocket expenses at the rate of Rs. 4000.00 per day, without production of vouchers.

For mediators not following the DAC Conciliation Fee Schedule, the conciliator fee will be based on the rates charged by the conciliator.

CONCILIATOR FEE

In Matters referred by Govt/Statutory Bodies fixed Conciliation Charges of Rs 5500/- is to be paid and born by the Party who has raised the Dispute irrespective of the claim amount. The defending Party is required to pay Rs 2500/- at the time of filing its reply to the Dispute.

At least 3 Conciliation sessions shall be hold by the Conciliator before concluding the conciliation proceedings except in cases where any of the parties themselves give in writing to terminate the conciliation proceedings.



Travel, Boarding & Lodging (CC & CCC) Conciliator:

Local Sitting: No Travelling allowance for Local sitting. Outstation Sitting: Actuals by Air, Rail or Car, plus out-of-pocket expenses at actuals for boarding, lodging and local transport subject to maximum of Rs. 4000.00 per day in Metropolitan cities and Rs. 3500.00 per day in other cities. A Conciliator who makes his own arrangements for boarding, lodging, local transport etc. may be paid out of pocket expenses at the rate of Rs. 2000.00 per day, without production of vouchers.

Travel, Boarding & Lodging (CSCC & DACCC) Conciliator:

Local Sitting: No Travelling allowance for Local Sitting sitting. Outstation Sitting: Actuals by Air, Rail or Car, plus out-of-pocket expenses at actuals for boarding, lodging and local transport subject to maximum of Rs. 5500.00 per day in Metropolitan cities and Rs. 6000.00 per day in other cities. A Conciliator who makes his own arrangements for boarding, lodging, local transport etc. may be paid out of pocket expenses at the rate of Rs. 4000.00 per day, without production of vouchers.

For Conciliator not following the DAC Conciliation Fee Schedule, the Conciliator fee will be based on the rates charged by the Conciliator.

To be paid by the Initiating Party at the time of filing of Request.

Conciliator & Administrative Fee:

Once the Conciliator is appointed, the initiating party shall make a deposit for 2 sessions of Conciliator fee and administrative fee. If the Conciliation is abandoned due the absence of the opposite party or due to non-agreement in the first session itself, the balance amount will be refunded to the initiating party.

After the first session, both parties shall always keep a deposit of Conciliator and administrative fee of 2 sessions in advance. After the conclusion of the Conciliation, the amount will be settled.

The fee shall be payable in equal shares by the parties except Statutory Conciliation, provided that where one party fails to pay his share, the other party may pay that share, provided further that where the other party also does not pay the aforesaid share, the conciliation proceedings may be suspended or terminated.

Rentals of Conference Rooms:

In case of Conciliation through Centre, the parties shall also pay rentals for the conference rooms and costs of coffee and snacks, as fixed by the centre.

TERMS

- The Conciliator and Administrative Fee (fee) will be fixed based on the claim, provided that where, apart from the claim, a counter-claim is also made, the fee will be fixed based on the claim or counter claim, whichever is higher.
- The fee shall be payable in equal shares by the parties, provided that where one party fails to pay his share, the other party may pay that share, provided further that where the other party also does not pay the aforesaid share in respect of the claim or the counter-claim, the conciliation proceedings may be suspended or terminated.
- In case of conciliations through Centre, the parties shall also pay rentals for the conference rooms and costs of coffee and snacks, as fixed by the centre.
- If the amount referred in conciliation is in a currency other than Indian Rupees, it shall be converted into Rupees at the current official rate of exchange.
- All amounts shall carry additional GST if applicable.
 - All payment shall be made by cheque/DD/Pay-Order drawn in the name of "Delhi Arbitration Centre" payble at New Delhi .
