6	From Rs 50,00,00,001 and above	Rs. 2,50,000/-

3	From Rs. 20,00,000 and upto Rs.1,00,00,000	Rs. 75,000/-, Plus 2.5 percent of the claim amount over and above Rs. 20,00,000/-
4	From Rs 1,00,00,001 to Rs. 10,00,00,000	Rs. 2,75,000/-, Plus 1 percent of the claim amount over and above Rs. 1,00,00,000/-
5	From Rs 10,00,00,000 and upto Rs.20,00,00,000	Rs. 11,75,000/-, Plus 0.75 percent of the claim amount over and above Rs. 1,00,00,000/-
